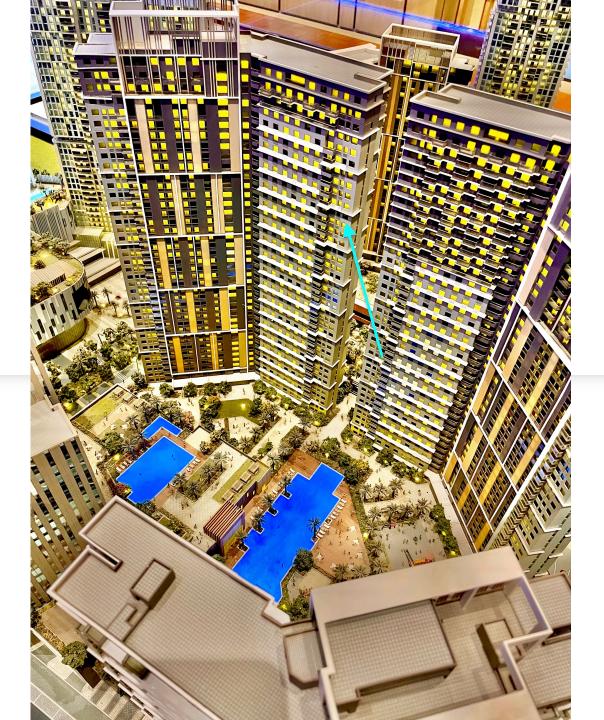


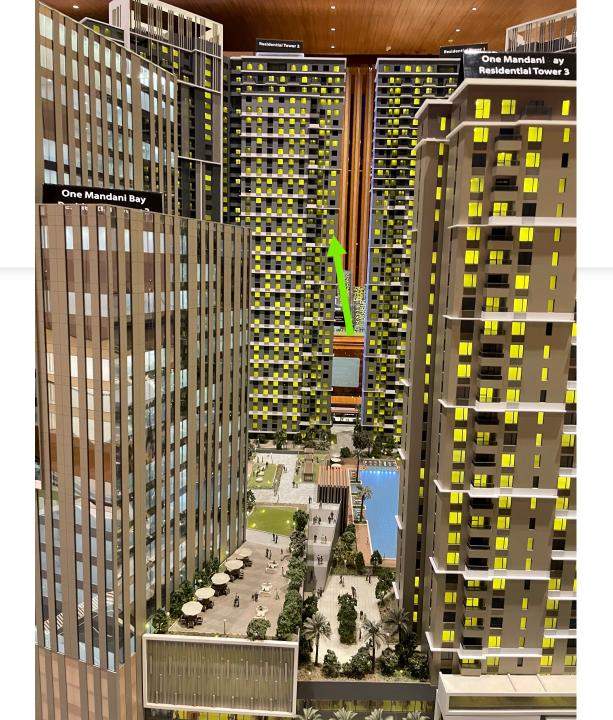

Location using scale model as reference

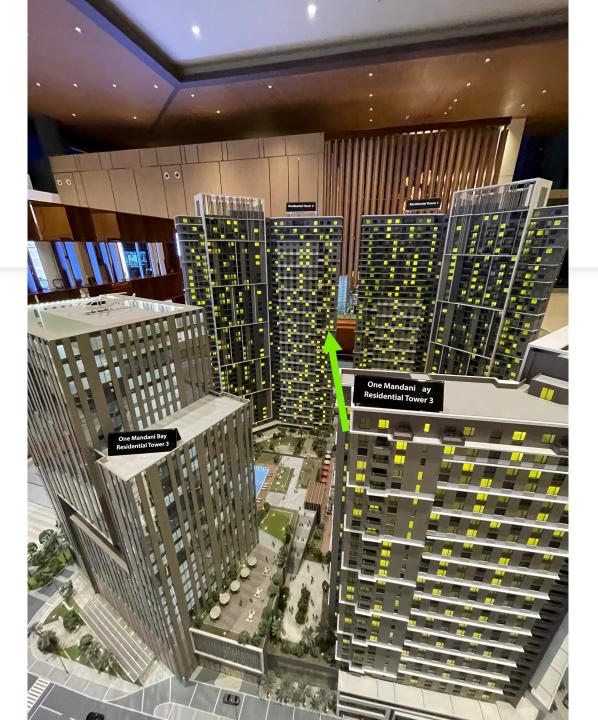
